Application & Permit for Use of Inflatable Jump House or Astro-Jump

It is unlawful for any person, group or organization to operate an inflatable Jump House or Astro-Jump in ANY City park or recreational area without the express written permission of the Director of Parks and Recreation, or the Director's authorized designee

Renter must provide a copy of Certificate of Liability insurance from the vendor with The City of Burlingame, Its Officers, Employees and Agents listed as the additional insured prior to the date of Washington Park Rental

All paperwork due two weeks prior to rental date - Only designated areas can be used for Jumpy House or Astro Jump
Use of Jumpy House or Astro-Jump only allowed in conjunction with a permitted picnic area in Washington Park

Fees: \$100 User Fee (In addition to picnic rental fees)

Cancellation Policy: You must notify Burlingame Parks and Recreation of any cancellations 14 business days before the reserved date to receive a check refund minus \$8.00 processing fee. Less than 14 business days notice will result in 50% reservation fee penalty not including an additional \$8.00 processing fee. Permit holder must call to obtain a full check refund for a rained out activity.

There are some limitations in regards to inflatable Jumpy Houses or Astro-Jumps in Washington Park

- 1) One inflatable per day
- 2) Inflatable Jumpy House or Astro-Jump can be no larger than 13x13
- 3) Water Course Inflatables, Obstacle Courses, Inflatables with slides and/or loose accessories i.e. balls are not allowed
- 4) No trucks, cars or motorized vehicles of any kind are allowed in Washington Park
